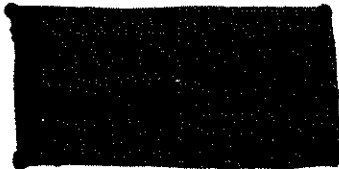

A search of the Division of Criminal Justice Services' (DCJS) files, using the fingerprint impressions submitted with your record review request, has resulted in an identification to a New York State case/criminal history report under NYSID number [REDACTED]. A second search of sealed records, based solely on the personal descriptive data you provided, has also been performed. Note that the sealed information, if included, is provided to you in accordance with subsection 2 of Criminal Procedure Law 160.50 and is only based on a search of the personal descriptive information you provided.
